1. Name

1.1 Club/Society Name: Mentis

2. Aim and Objectives

- 2.1 The Aim of the Society shall be to

5. Club/Society Officials

- 5.1 An elected committee will conduct the running of the Society.
- 5.2 The committee shall ensure that the Society abides by this Constitution.
- 5.3 The committee will consist of the following officers who shall be members of SGSU:

- President or Co-Presidents
- Vice-President
- Treasurer
- Secretary
- Communications Officers
- Events/Conference Leads

The committee will serve for one academic year.

6.0 Duties of Club/Society Officials

6.1 The President or Co-President is/are responsible for:

- Chairing of meetings
- Organising Society Events
- Main Contact to Student Union
- Setting Society Agendas and Identifying Targets
- Following up committee's roles
- Communicating with committee members to ensure deadlines are met

6.2 The vice-president is responsible for:

- Chair of meetings
- Supporting role of President Including organisation of events
- Ensuring SU Regulations adhered to

6.3 The Treasurer is responsible for:

- Securing membership fees and cost of events
- Recording Ingoing and outgoing cash flow
- Determining cost of activities and events
- Paying for venue hire if necessary
- Communicating with Finance Officer for NSPC

6.4 The Secretary is responsible for:

- Room Bookings
- Arranging Meetings, including booking of room
- Collecting agenda points from other committee members before meeting
- Recording Minutes

6.5 The Communications Officers are responsible for:

- Advertisement of events online
- Sending out emails of events
- Updating SU Website page and social media pages

6.6 The Conference/Events Lead

- Act as a decision maker for organising conference or events
- Appointing a team for running events and conferences

 Act as a bridge between the conference committee and the SGUL Psychiatry Society Committee

7.0 Meetings

- 7.1 The Society Committee shall meet regularly during term time
- 7.2 Regular Committee meetings are required to discuss all Society matters. Minutes shall be made available to SGSU for ratification.

8.0 Voting

- 8.1 This will take place for the election of Officials and any other issue that the Society deems of importance.
- 8.2 Only Society members will be entitled to vote.
- 8.3 The results of any election shall be passed to the Sports/Societies Officer and the General Secretary of SGSU at the earliest opportunity.

9.0 Changes to the Club/Society Constitution

- 9.1 Changes can be implemented if a two-thirds majority is obtained at an annual or extraordinary general meeting of the Society.
- 9.2 Any changes shall be deemed provisional until passed to the Societies Officer and the General Secretary of SGSU at the earliest opportunity and subsequently ratified.
